And the said party to whom this permit is issued to is hereby authorized to use for depositing  
building material, not more than one-third of the roadway of the street, nor more than one-half of the  
sidewalk in front of said premises, provided that the gutter shall be bridged over and kept clear, so as  
not to obstruct in any way the flow of water, and that in case it is necessary to remove all the sidewalk,  
a good and safe sidewalk shall be maintained at all times over the gutter or elsewhere, the Building  
Inspector may direct, and provide further, that said party shall maintain, at all times, good and secure  
barricades around all openings or dangerous places and shall provide, and properly place, red lights at  
each end of all obstructions or building materials in said street, and keep the same burning brightly from  
sunset to sunrise every night, as provided by the laws of the Town relating to public safety. This permit  
to occupy any part of a public street expires on

And I hereby agree and bind myself, in consideration of the granting of said permit, to construct  
said building in accordance with all the requirements of the Ordinances of the Town and in a good,  
substantial and workmanlike manner, to the satisfaction of the Building Inspector. And I further agree  
that I will, in operating under this permit, observe and conform in all respects to the provisions of  
Resolution No. 12, Series 1984, and to assume and be responsible for all liabilities thereon prescribed.
