MINUTES OF A WORKSESSION OF THE FAIRPLAY BOARD OF TRUSTEES January 25, 2010

CALL TO ORDER AT 6:00 PM:

A meeting of the Board of Trustees for the Town of Fairplay was called to order at 6:05 p.m. in the Fairplay Town Hall, 400 Front Street, by Mayor Fred Boyce. Roll call was answered by Trustees Greg Johnson, Keith Wortman, John Deagan and Gabby Lane. Discussion Regarding Proposed Ordinance Regulating Medical Marijuana Dispensaries

At the conclusion of the discussion, staff was directed to place on the February 1 agenda, both an ordinance extending the moratorium and the proposed ordinance regulating dispensaries – with included changes from this work session. It was agreed that this would offer the Board and staff time to review possible legislative action being proposed by the state and to further review the proposed ordinance.

Discussion Regarding Loan/Lease Purchase for Radio Read Water Meter Reading System

Staff comment was offered by Town Treasurer Murray offering two scenarios for financing the Water Enterprise's purchase of a radio read water meter reading system. Scenarios presented were: 1) a loan through UMB Bank of Colorado or 2) a lease purchase though Colorado East Bank and Loan. She explained the pros and cons of each scenario with particular attention to the advantage of the loan over the lease-purchase in regards to the ability to pay off the principal amount borrowed without penalty or interest at any point in the loan process. After discussion, the Board directed Ms. Murray to pursue the loan option with UMB bank.
