MINUTES OF THE REGULAR MEETING OF THE FAIRPLAY BOARD OF TRUSTEES August 19, 2013

CALL TO ORDER REGULAR MEETING OF THE BOARD OF TRUSTEES

The regular meeting of the Board of Trustees for the Town of Fairplay was called to order at 7:00 p.m. in the Council Chambers located in the Fairplay Town Hall, 901 Main Street, by Mayor Gabby Lane who proceeded with the pledge of allegiance, followed by the roll call which was answered by Trustees Eve Stapp, LaNita French, Ray Douglas and Frank Just. Also in attendance were Town Attorney Lee Phillips, Public Works Director Gary Donnelly, Town Treasurer Kim Wittbrodt and Deputy Town Clerk Claudia Werner.

AGENDA ADOPTION

Motion #1 by Trustee Just, seconded by Trustee French, that the agenda be adopted as presented. Motion carried unanimously.

Deputy Town Clerk Werner provided a staff report wherein she states that all necessary documents and fees have been received and the hearing has been noticed in accordance with Colorado Revised Statutes, therefore staff recommends approval of this application.

UNFINISHED BUSINESS

A. <u>Other Pending/ Outstanding Items</u>

1. <u>Beach Dredging Project</u>

Public Works Director Donnelly provided a written report, wherein he stated that the water level has dropped hindering the dredging of the sandbar at the north end of the reservoir but the rest of the project is staying within budget and on schedule. He went on to report that a private party is paying a local trucking company to haul off the silt and sand, freeing up some of the Town's resources.

2. <u>CNG Project</u>

Public Works Director Donnelly stated that there is a two man crew working without a compactor on the repairs, but CJ's Construction is still not on site. Gary went on to suggest that he may need to talk with someone within the CNG organization that oversees the local employees about getting this work expedited.

Attorney Phillips reiterated that the Town holds four \$50,000.00 street cut bonds on this project and if additional recourse is necessary to get the repairs completed the Town can sue CNG for damages and/or revoke their franchise agreement.

The Board directed Attorney Phillips to send an ultimatum letter to CNG.

3. <u>Streetlights</u>

Police Chief Gottschalk provided a staff report, wherein he stated that the Xcel Energy engineer that came over to do the assessment and walk through for this project has left the company. Dave went on to say that he has made contact with another employee in their Silverthorne office and is still waiting for the cost estimate.

4. <u>Code Enforcement</u>

Nothing new to report at this time.

5. <u>Fee Schedule Update</u>

Town Treasurer Wittbrodt reported that she is still working on these updates.

B. <u>Other Discussion Items</u>

Public Works Director Donnelly reported that the excavation for the 6th Street sidewalk between Castello Avenue and Clark Street has been completed in preparation for the concrete that will start arriving next week. He went on to say that the Town will need to do a section of sidewalk on 8th Street adjacent to the Park County RE-2 School campus. This additional work will start once the 6th Street sidewalk is completed.

NEW BUSINESS

A. Should the Board Approve Adoption of Resolution 2013-11, entitled, "A RESOLUTION OF THE BOARD OF TRUSTEES FOR THE TOWN OF FAIRPLAY, COLORADO, AUTHORIZING THE EXECUTION OF A LEASE AGREEMENT BETWEEN BOB WHITE AND THE TOWN OF FAIRPLAY FOR THE USE OF 523 FRONT STREET".?

Deputy Town Clerk Werner provided a written staff report wherein she stated that Bob White has agreed to enter into a lease with the Town of Fairplay for the sum of \$1.00 for his building located at 523 Front Street for the Town's use during the Plein Air Arts Celebration to be held September 3 - 7, 2013. The recommended action was to approve Resolution 2013-11.

Motion #4 by Mayor Lane, seconded by Trustee Just, to approve adoption of Resolution 2013-11, entitled, "A RESOLUTION OF THE BOARD OF TRUSTEES FOR THE TOWN OF FAIRPLAY, COLORADO, AUTHORIZING THE EXECUTION OF A LEASE AGREEMENT BETWEEN BOB WHITE AND THE TOWN OF FAIRPLAY FOR THE USE OF 523 FRONT STREET". A roll call vote was taken: Stapp – yes, French – yes, Lane – yes, Douglas – yes, Just – yes. Motion carried unanimously.
